For employers who prefer virtual interviews, we'll have a room reserved for virtual interviews.

All accredited law schools in California, and others throughout the country, will be invited to participate and will be provided with a list of participating employers. Eligible students will designate employers with whom they would like to interview and employers will then have the opportunity to review the resumes of those students interested and select the students to which to extend interview invitations.

Students will begin creating profiles to be considered for open positions today, and will be asked to complete their profiles by July 23, 2024. To the extent positions are open and students are matched, you may begin selecting students for interviews from July 15, 2024 to July 31, 2024.

The participation fee for employers is \$1,295.00 for scheduled in-person and/or virtual interviews. Upon completion of the registration form, an invoice will be sent to the email address(es) provided on the registration form.
